- ❖ Rebates are in place through December 15, 2017 or until funds are depleted.
- ❖ Please allow 8 to 10 weeks to process the rebate/incentive application.
- ❖ Appliance recycling qualifies for the entire rebate, regardless of the recycling cost.
- ❖ Visit www.energystar.gov to verify ENERGY STAR rating.
- ❖ The rebate application must be received no later than 3 months after the purchase or by December 15, 2017, whichever comes first. Please include:
 - ✓ This rebate form
 - ✓ A copy of your receipt or invoice for each item purchased
 - ✓ ENERGY STAR label for each item purchased
 - ✓ For recycled appliances, include receipt for each item showing unit is in working order
