ENERGY EFFICIENCY IMPROVEMENTS (RECOMMENDED IN AUDIT OR ASSESSMENT) 2018 Energy Efficiency Rebate Form

ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM *(Please read)*

- ❖ Member may qualify for 20% of the cost of energy efficiency improvements up to \$500 (cost can only include material and professional labor).
- ❖ Energy Efficiency improvements must be recommended during an audit or assessment arranged by your cooperative or a cooperative approved partner. The audit must be a comprehensive audit including a written report.
- ❖ Home or farm being improved must be on cooperative's lines.
- ❖ Rebates are in place through December 14, 2018, or until funds are depleted. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ The following deadlines apply:
 - Energy efficiency improvements must be completed within 24 months of the audit date.
 - After improvements are completed, apply for rebate within 3 months of completion date, or by December 14, 2018, whichever date comes first.
- ❖ Required documentation:
 - This Rebate Form
 - A copy of your receipt or invoice for each implemented measure
 - Copy of the Audit Documentation
 - Documentation showing improvements have been completed
