## Members Enjoy Refund Checks

Barron Electric returned \$2.6 million to members who were on the lines from 2007-2012 as part of the settlement from the Nuclear Waste Policy Act (NWPA) of 1982. The NWPA stated that the United States Government would provide long-term storage of spent nuclear fuel. The government failed to take the nuclear waste from Dairyland's shutdown nuclear power plant in Genoa. Dairyland Power Cooperative, Barron Electric's power supplier, won a \$73.5 million settlement from the U.S. government. This is the second award Dairyland has received for having to store the spent fuel, which remains in dry casks at the Genoa plant site. Although Dairyland Power is in the process of decommissioning the shutdown nuclear plant, it still costs \$3 million annually for security of the spent fuel. Former member Shirlee Lucken remarked, "The check was a nice surprise." More than 19,000 current and former members received a refund.

# Wisconsin's Business Climate Attracts Peragon

## History

Heath Copp and Matthew Johnson were searching for truck bed covers, but were unsuccessful in finding ones to meet their needs. After making a list of what they wanted, they built their first prototype out of Legos. The second prototype followed and was created using plywood. These prototypes led to Peragon's beginning, which was formed in 1999 and based out of Grand Forks, North Dakota. The company later moved to Minnesota, then to Wisconsin

in 2013. Heath remarked, "The business climate in Wisconsin and the support of the local economic development drew us here. Wisconsin is definitely open for business." A recent move from Spooner to Shell Lake has given Peragon a larger facility with room to grow. We are always evaluating innovative new products, while continuing to improve our current product."


visited patients, libraries, and the University of Wisconsin-Barron County during finals week to help reduce stress.

- Director Helm reported on activity of total receipts in the office - \$1,283,018; total receipts by wire and ACH- \$642,560; disbursements by ACH, EFT, wire - \$1,067,205; transfer of funds was made for payroll - \$171,509 and power bill paid 10/25/17 in the amount of \$1,876,993. A membership list of 88 was presented and approved by the board.
